## COMMERCE & TRANSPORT (TRANSPORT) DEPARTMENT NOTIFICATION

The 7th March, 2014

No. 1586-LC-TR-Case-03/2013/T.— In pursuance of the powers under clause(iii) of the proviso to sub-rule (1) of rule 108 and sub rules-(4) & (6) thereof the Central Motor Vehicles Rules, 1989 and in supersession of the Notification No. 5860-LC-II-Case-3/2010/T, dated the 27th September,2010 published in the *Odisha Gazette* Extraordinary No. 1676, dated the 12th October,2010 and No. 7389-LC-TR-Case 29/2012/T., dated the 22nd November, 2012 published in the *Odisha Gazette* Extraordinary No. 2185, dated the 23rd November, 2012, and in pursuance of the orders dated the 10th December, 2013 of Hon'ble Supreme Court of India passed in Special Leave Petition (Civil) No.25237 of 2013, Government have been pleased to decide that the following arrangement is made for use of Red light and Amber light by the dignitaries and officials respectively on the top front of their vehicles.

(A) Red light with flasher while on duty:—

1. His Excellency Governor of Odisha
2. Chief Minister, Odisha
3. Chief Justice of Orissa High Court.
4. Speaker, O.L.A.
5. Cabinet Ministers
6. Leader of the opposition, Odisha Legislative Assembly
7. Judges of Orissa High Court

(B) Red Light without flasher while on duty:—

8. Deputy Speaker, O.L.A.
9. Ministers of State
10. Deputy Ministers

(C) Officials entrusted with law & order and other emergency services to use Amber light on their vehicles while on duty.

1. Director General & Inspector General of Police.
2. Commandant General, Home Guards & Director General & Inspector General of Police, Fire Services.
3. Vehicles used by Senior Supervisory Officers directly dealing with Law & order namely Range I.G. / D.I.G. / I.G.P. ( Law & Order) / D.I.G.P. ( Law & order) / Commissioner of Police/ Additional Commissioner of Police/ Deputy Commissioner of Police.
4. Revenue Divisional Commissioner
5. District Magistrate / Additional Dist. Magistrate/ Sub-Divisional Magistrate / Executive Magistrate.
6. Police vehicles on Patrolling duty & P.C.R. Vans.
7. Police vehicles used for carrying / conveying forces for Law & order duty
8. Fire Service vehicles on duty

In case the vehicle is not carrying the dignitary/ official then the red light / Amber light as the case may be, shall not be used and be covered by black cover.
