
No. LC-TR-CASE-01/2017/ 3897 /T., In pursuance of powers conferred under clause (iii) of the proviso to sub-rule (1) of Rule 108 and sub-rule (4) and (6) of Central Motor Vehicles Rules, 1989, Government of Odisha had specified the list of dignitaries / officials authorized to use red / amber / blue light etc. on top of the vehicles vide Notification No.1586/T. dated 07.3.2014, No.-3292/T. dated 16.5.2015, No. 1001/T. dated 11.02.2016 and No.2782/T dated 26.4.2016.

In the meantime, Ministry of Road Transport & Highways, Govt. of India have amended the provisions of Rule 108 of CMV Rule vide Govt. of India Gazette No. G.S.R. 423(E) dated 01.05.2017 by omitting certain clauses and sub-rules therein.

In view of the above mentioned Amendment in CMV Rules, the aforesaid Notifications issued by Govt. of Odisha in Commerce and Transport (Transport) Department are not in force w.e.f. 01.05.2017.

This is for information and necessary action of all concerned.


