No.LC-TR-16/2013 2525 /T., dated 26/4/14

The freight for goods Carriages was last fixed vide this Department Notification No.LC—IV-Con-08/2008-9069/T dated 15.11.2008. Similarly, the freight for goods carriages plying within and outside the districts of Keonjhar, Jajpur, Sundargarh and Angul carrying coal / iron ore / minerals was fixed vide this Department Notification No.LC-TR-79/2011-1101/T. dated 23.02.2012.

In the meantime, after careful consideration, it has been decided by Government that the State would dispense with the prevailing system of fixing freight rates of goods carriages and proactively facilitate free and competitive business environment in the trade and industry to create a healthy economic environment conducive for growth as in all other States. Thus, the freight rates are to be determined by the market forces in a competitive environment.

Accordingly, the notifications issued vide this Department Notification No. 9069/T. dated 15.11.2008 and No. 1101/T. dated 23.02.2012 are rescinded.
