NOTIFICATION

No.315-LC-TR-32/2014(Pt.)/T.— Whereas, the draft of certain rules further to amend the Odisha Motor Vehicles Rules, 1993 was published as required under sub-section (1) of Section 212 of the Motor Vehicles Act, 1988 (59 of 1988) in the Extraordinary issue No.2112 of *Odisha Gazette* dated the 9th December, 2014 under the Notification of the State Government of Odisha in Commerce & Transport (Transport) Department Notification No. 8174-LC-TR-32/2014(Pt.), dated the 3rd December, 2014 inviting objection or suggestions from all persons likely to be affected thereby till the expiry of a period fifteen days from the date of publication of the said Notification in the *Odisha Gazette*.

And, whereas, no objection or suggestions have been received in respect of the said draft.

Now, therefore, in exercise of the Powers Conferred by Section 28 of the said Act, the State Government do hereby make the following rules further to amend the Odisha Motor Vehicles Rules, 1993, namely:—

1. (1) These rules may be called the Odisha Motor Vehicles (Amendment) Rules, 2015.

(2) They shall come into force from the date of publication in the *Odisha Gazette*.

2. In the Odisha Motor Vehicles Rules, 1993 in Chapter-II, after rule-8, following rule shall be inserted namely:—

“8A- Evidence as to the correctness of address and age:- Every applicant for issue of Driving License under Chapter-II of the Motor Vehicles Act, 1988 shall produce any one or more of the following documents in original or relevant extracts thereof duly attested by him/her as evidence of his/her address and age.

1. Service Identity Card with photograph and date of birth issued to employee. of Central, State Government, public sector undertakings, public limited companies.
2. Pass Books with photographs issued by the Nationalized Bank or Post Office.
3. PAN Card.
4. Aadhar Card.
5. Smart Card issued by Registrar General of India (RGI) under National Population Register.
6. Pension Payment order with photo.
7. MNREGA (Mahatma Gandhi National Rural Employment Guarantee Act) Job Card issued in Noand dated the.....
8. Health Insurance Smart Card issued under Rashtriya Swasthya Bima Yojana of Ministry of Labour & Employment, Government of India".
