Whereas the draft of certain rules further to amend the Odisha Motor Vehicles Rules ,1993 was published as required by sub-section(1) of Section 212 of the Motor Vehicles Act ,1988 (59 of 1988), in the Extraordinary issue No.1346 of the *Odisha Gazette* dated the 24<sup>th</sup> September,2015 under the Notification of the Government of Odisha in the Commerce and Transport (Transport) Department No.5990- No.LC-TR-1/2015(Pt.-III)/T dated the 15<sup>th</sup> September,2015 inviting objections and suggestions from all persons likely to be affected thereby till the expiry of fifteen days from the date of publication of said Notification in the *Odisha Gazette*;

And, whereas, no objection or suggestion has been received in respect of the said draft;


Now, therefore , in exercise of the powers conferred by section 111 of said Act, the State Government do hereby makes the following rules further to amend the Odisha Motor Vehicles Rules ,1993 namely: -

- (1) These rules may be called the Odisha Motor Vehicles (Amendment) Rules,2015.
- (2) They shall come into force from the date of their publication in the *Odisha Gazette*.

2. In the Orissa Motor Vehicles Rules, 1993 for the table below sub-rule(3) of rule 129-A specifying the amount of pollution testing fees, the following table shall be substituted, namely:-

Sl. No.	Type of Vehicle		Revised Rates (including cost of the computerized photo)
1.	Two and Three wheelers	-	Rs.60.00
2.	Light Motor Vehicle	-	Rs.100.00
3.	Medium and Heavy Motor Vehicle	-	Rs.150.00


