**NOTIFICATION**


No. LC-TR- 111 /2016/ 2560 /T., dated. 07/4/17

In exercise of the powers conferred by section 165 of the Motor Vehicles Act, 1988 (59 of 1988) and in continuation of the notification of the Government of Odisha in Commerce & Transport (Transport) Department No.7644 dated 06.11.2013, 296 dated 15.01.2015, 1072 dated 13.02.2015 and 7420 dated 21.10.2016, the State Government do hereby constitute the Motor Accident Claims Tribunals in the State of Odisha and appoint the Additional District and Sessions Judge as mentioned in the column (2) of the Schedule, in respect of their jurisdiction as specified in column (3) thereof, as the Member of the Motor Accident Claims Tribunal in respect of its jurisdiction for the purpose of adjudicating upon claims for compensation in respect of accidents involving the death of, or bodily injury to, persons arising out of the use of motor vehicles, or damages to any property of third party so arising, or both.
