2. Where there are more than one Superintendent of Police, Executive Engineer, Roads, Executive Engineer, National Highways, District Transport Manager, each such officer shall be a member.

3. Where there are more than one Regional Transport Officer in the District, the Regional Transport Officer at the District headquarters shall be the Convener and the other shall be a member.

4. The Committee shall—

- (i) advise on all matters pertaining to Planning & Coordination of Policies, Practices and Standard of Safety in the Road Transport Sector;
- (ii) formulate and recommend road safety programmes for implementation by Road Safety Organization within the District.
- (iii) suggest areas for research and development to improve safety aspects in the Road Transport Sector including maintenance of statistics of road accidents and their analysis; and
- (iv) generally oversee and monitor the road safety measures undertaken in the District.

5. The Committee will hold its meeting every month.
