RESOLUTION

The 17th October, 2017

Sub: Restructuring of the Cadres of OTES & OSTES and introduction of OTS Cadre under the Transport Department.

The proposal of restructuring of the **Odisha Transport Engineering Service (OTES)** and **Odisha Sub-ordinate Transport Engineering Service (OSTES)** has been under consideration of the Government for some time past. After careful consideration, Government have decided to restructure the OTES and OSTES in the manner as in **Part A**.

Besides these two technical cadres, a group of general service officers are working under Transport Department since its formation i.e. Asst. R.T.O, Addl. RTO (General) and R.T.O. (General). Their induction and promotion have been regulated on the basis of the Executive Instructions issued from time to time. In order to regulate their service conditions, Government have decided to organize these officers by constituting a new cadre namely '**Odisha Transport Service (OTS)**' in the manner as in **Part B**.

A: Restructuring of the OTES and OSTES:

1. The base level posts of the OTES cadre i.e. Inspector of Motor Vehicles (I.M.V)/Addl. RTO (Enforcement)/Assistant Works Engineer, in level 10 of the Pay Matrix under ORSP Rules, 2017, shall be upgraded to Group-A (Junior Branch) in level 12 of the Pay Matrix under ORSP Rules, 2017.
2. The R.T.O. posts which are at present in level 12 of the Pay Matrix under ORSP Rules, 2017, shall be upgraded to Group-A (S.B) in level 13 of the Pay Matrix under ORSP Rules, 2017.
3. Odisha Sub-ordinate Transport Engineering Service (OSTES) Cadre which presently consists of Junior MVIs only, shall hence-forth consist of Junior MVIs and Assistant MVIs. 32 posts of Junior MVI shall be upgraded and named as Assistant MVI in level 10 of the Pay Matrix under ORSP Rules, 2017. The remaining posts of

Jr. MVIs shall continue to be in the same pay as in level 9 of the Pay Matrix under ORSP Rules 2017.

- Initially, 32 posts of Jr. MVIs along with incumbents as per seniority, shall be upgraded as Asst. MVIs. Subsequently the vacant posts of Asst. MVIs shall be filled up by way of promotion.

B Formation and Restructuring of cadre for General Service Officers:

- The general service officers functioning under the Department will be organized in the new cadre namely "Odisha Transport Service".
- Odisha Transport Service (OTS) cadre shall consist of the existing posts namely (i) Assistant RTO (ii) Additional RTO (General) and (iii) RTO (General).
- Post of Asst. RTO, presently in level 9 of the Pay Matrix under ORSP Rules, 2017 shall be upgraded to level 10 of the Pay Matrix under ORSP Rules, 2017.
- Post of Addl. R.T.O. (General) presently in level 10 of the Pay Matrix under ORSP Rules, 2017 being equivalent to IMV/Addl. RTO(Enf)/AWE, shall be upgraded to Group-A in level 12 of the Pay Matrix under ORSP Rules, 2017.
- Post of R.T.O.(General) at present in level 12 of the pay matrix, shall be upgraded to level 13 of the Pay Matrix under ORSP Rules, 2017.
