Sub: Allowing Travel Concession to the Passengers with Immune Deficiency (HIV/AIDS) in all Government & Private stage carriages operating in the State.

In consideration of the recommendation of the Odisha State Council on AIDS and the proposal of the Ministry of Road Transport & Highways, Govt. of India to make a suitable provision of free transport to the persons living with HIV/AIDS for their journey to the ART Centres for prevention and control of HIV/AIDS, the Government of Odisha, after due consideration, have been pleased to allow free travel to persons with Immune Deficiency (HIV/AIDS) while travelling in the Government & Private stage carriages operating in the State.

2. Such concession shall be made available on production of Identity Card/Medical Certificate from the Competent Authority, i.e. State AIDS Cell, in support of such claim.

Ordered that the Resolution be published in the Extra Ordinary issue of the Odisha Gazette.




