### NOTIFICATION

The 16th June, 2016

No. 4555-LC-TR-14/2015 (Pt.-I)/T.— It has been decided to extend the BGGY Scheme (Phase-III) to all the unconnected Gram Panchayats of the remaining 13 Districts (Angul, Bhadrak, Cuttack, Dhenkanal, Ganjam, Jagatsinghpur, Jajpur, Jharsuguda, Kendrapara, Khurda, Nayagarh, Puri & Bargarh) and all the unconnected Gram Panchayats of Non-ITDA Blocks of Phase-I Districts (Balasore, Sambalpur, Gajapati, Keonjhar & Kalahandi) of the State with partial modification to the clauses appearing in the "Biju Gaon Gadi Yojan" Scheme and in the earlier Notification bearing No. 6243/T., dated the 27th October, 2014 of Commerce & Transport (Transport) Department. Further, some modifications in the few existing clauses have been made as follows

(including to & fro journey) shall be identified which can ensure connectivity to maximum number of Gram Panchayats with the Block headquarters/ nearest town/ main road junction.		single assured service instead of two services which is to be allowed by Department on case to case basis, on due recommendation by the Committee at District/ Sub division / Block level.

2. On revenue considerations, the following modifications have been made which are applicable for only Phase-III areas.

- (a) Districts shall extend the existing route permits (Stage Carriage) without bringing them under the fold of BGGY.
- (b) In case of non-availability/ shortage of private operators for plying of vehicles owing to geographical condition/ commercial viability / socio-economic conditions/ other development parameters, districts shall allow to connect the unconnected GPs by extending BGGY for Phase-III.
- (c) The BGGY vehicles should not ply in areas coming under Municipal Corporations.
- (d) The incentives available for vehicles under BGGY are as indicated below:

3. The above modifications shall be deemed to have come into force on 2nd December, 2015.
