- 2.Persons against whom Department Proceeding or criminal cases are pending/ contemplated or who have been penalized for misconduct are not eligible for consideration.
- 3.The engagement will be valid for period of 01(One Year) from the date of engagement or till filing up of the regular vacancy, whichever is earlier.
- 4.The consolidated remuneration will be fixed as per Finance Department Office Memorandum No.24533/F., dated. 29.09.2022.
- 5.The period of such engagement shall not be counted as Government Service for the purpose of Pension and any other retirement benefits.
- 6.The engaged person shall be subject to the Odisha Government Service Conduct Rules, 1959 as amended from time to time and shall be liable to be prosecuted for their misconduct, omissions
