Addendum to Tender Call Notice No.D-153 for supply of dietary and other miscellaneous articles in respect of different Jails for the year 2025-26.

Pursuant to the Tender Call Notice No. D-153 in respect to our Tender Call Notice dated 25th October, 2024 for supply of Principal food grains and other misc. articles including vegetables, chicken, eggs, milk, paneer etc. published in the Odia, English daily News Paper, "The Samaj" and "Times of India", the following term & condition is added in the Tender Call Notice.

"1- To ensure timely supply of proper articles as per store order, the bidder/ tenderer shall be restricted to participate in the tender process of maximum 03 Jails only.
